**All Modified Cars, both with or without** factory fitted OEM four-wheel disc brakes and/or OEM driver's airbag, **12.000 seconds (1/4 mile) / 7.643 seconds (1/8 mile)** and slower.

A standard swingarm for the model, forks, brake callipers and road legal tyres must be utilised and the original wheelbase of the motorcycle must be maintained.
